

Membership Terms.

In accordance with the Statutes and Fees Regulation of the Associação de Solidariedade e Desenvolvimento Social – ASDS, which can be consulted at any time at www.asdsocial.pt, I have read and I accept without reservation the following:

- 1) The act of joining ASDS, duly formalized by the following procedures, establishes a contractual relationship between myself and ASDS, by which I agree to contribute to the fulfillment of the association's purposes, through payment of the membership fee, enjoying in return the benefits reserved to the associates.
- 2) The present registration document constitutes a proposal to join ASDS as an adherent member.
- 3) The date of this document is the date of adhesion to ASDS, unless otherwise provided explicitly by the parties.
- 4) Admission to ASDS only becomes effective after successful collection of the first regulatory fee.
- 5) Acquisition of the quality of adherent member by all members of the household constitutes a condition for benefiting of any and all services provided directly or indirectly by the association.
- 6) Admission of minors to the benefit of the quality of adherent member requires the intervention of their legal representatives.
- 7) The fee is 1 (one) Euro per month, being free for all other members of the household.
- 8) The first fee is due from the first day of the month following the date of registration with ASDS.
- 9) Payment is made in advance of 12 (twelve) monthly fees.
- 10) The monthly amount is due in full regardless of the date of withdrawal from the association.
- 11) In case of withdrawal before the end of the paid annuity, unused monthly fees will be refunded.
- 12) The fee annuity is paid by authorized debit from a bank account, under the terms legally applicable to the SEPA mandate. By subscribing this authorization, you authorize the Associação de Solidariedade e Desenvolvimento Social – ASDS to send instructions to your bank to debit your account and your bank to debit your account in accordance with the instructions from Associação de Solidariedade e Desenvolvimento Social – ASDS. As part of your rights, you are entitled to a refund from your bank under the terms and conditions of your agreement with your bank. A refund must be claimed within 8 weeks starting from the date on which your account was debited. Your rights are explained in a statement that you can obtain from your bank.
- 13) I am aware and accept that the collection operations are carried out on behalf of ASDS by Easympay, a payment institution authorized by the Bank of Portugal under number 8706, to which ASDS has given an express mandate for this purpose.

- 14) The effective subscription of a new associative benefit is dependent on the prior payment of the fee that might be due.
- 15) Delays in paying dues may result in suspension of benefits or cancellation of membership in the Association under the terms of Article 12 of the Statutes.
- 16) Leaving the association must be requested in writing, by letter or email to the ASDS administration board.
- 17) The linkage with the association can only be ended if the applicant no longer enjoys any associative benefit.
